#### Legality and quorum

Invitation to a meeting of the Student Union Council shall be delivered electronically for all members of the Student Union Council, and the meeting shall be announced at the official bulletin board of the Student Union at least seven (7) days before the meeting.

The Student Union Council constitutes a quorum when at least twenty-one (21) members and the Chair or the Vice-Chair are present. (TYY Rules Section 12)

The matters on the agenda of a meeting shall be informed in the invitation to the meeting. A matter not mentioned in the invitation to the meeting shall not be decided unless declared urgent with a two thirds (2/3) majority or unless the matter needs to be decided, according to the Rules, by a certain date and a new meeting can no longer be invited to decide the matter.

Upon invitation to the meeting, the agenda shall also be delivered to the deputy members of the Student Union Council. (TYY Administrative Rules Section 1)

Appendix 3 Review on making the employment contract of the Editor-in-Chief of Turku Student Newspaper half-time

> In its November 2023 meeting, the Student Union Council has approved a resolution according to which TYY Office and the Executive Board together prepare a review on making the employment contract of the Editor-in-Chief of Turku Student Newspaper half-time. The 2023 Chair of the Executive Committee of Turku Student Newspaper had recorded the preparation of the review in the annual planning cycle of the 2024 Executive Committee and in the testament of the Chair. The Executive Committee launched the review in its January meeting in 2024.

> The review goes through the previous reviews about Turku Student Newspaper conducted by Luotsi ry, the expense structure of Turku Student Newspaper, legal affairs related to changes of employment contract, a review of the Editor-in-Chief of their use of their working time and consideration of the future prospects of the staff of Turku Student Newspaper.

> According to Section 2(7) of the Regulation on Turku Student Newspaper, the Executive Committee has a general competence in matters concerning Turku Student Newspaper



within the framework of the plan of action and budget approved by the Student Union Council.

Proposal: The Executive Committee of Turku Student Newspaper proposes that the Student Union Council records the review on making the employment contract of the Editor-in-Chief of Turku Student Newspaper half-time.


